## Data processing information clause and statement

Information clause for participants of the 43rd edition of Ale Kino! International Young Audience Film Festival.

## Please be informed that:

- 1. The controller of your personal data within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as the GDPR, is: Centrum Sztuki Dziecka w Poznaniu with its registered office in Poznań, at: ul. Św. Marcin 80/82.
- 2. The controller has appointed a Data Protection Officer who may be contacted at: iod@rodo.pl.
- 3. Your personal data will be processed for the following purposes:
- a. your participation in, further contact regarding and promotion of the 43rd edition of Ale Kino! International Young Audience Film Festival the legal basis for the processing of your personal data in this case is the consent you have given (Article 6(1)(a) of the GDPR);
- b. tax settlements and keeping accounting records the legal basis for the processing of personal data in this case is the necessity to fulfil a legal obligation incumbent on the Controller (Article 6(1)(c) of the GDPR);
- c. establishing and pursuing any claims or defending against such claims by the Controller the legal basis for data processing is the Controller's legitimate interest (Article 6(1)(f) of the GDPR).
- 4. Providing the following personal data: name, surname, country, gender, e-mail address, telephone number and confirmation of being over 18 years of age is voluntary, but necessary to participate in the 43rd edition of Ale Kino! International Young Audience Film Festival.
- 5. Your personal data may be transferred to the following entities: the Controller's employees and associates, IT service providers, entities providing legal and advisory services, accounting and bookkeeping services, telecommunications services, ICT services such as hosting, maintenance of IT systems and the Filmchief platform provider. Your personal data may also be made available to bodies and authorities authorised by law to process such data.
- 6. Data processed on the basis of your consent will be processed until the consent is withdrawn, and within the remaining scope in accordance with the law or until claims become time-barred.
- 7. The Controller does not intend to transfer your personal data outside the EEA.
- 8. You have the following rights in relation to the processing of your personal data:
- where the legal basis is Article 6(1)(a) of the GDPR:
  - o the right of access to your data,
  - o the right to rectification of your data,
  - o the right to erasure of your data (right to be forgotten),

- o the right to restrict processing,
- o the right to data portability,
- where the legal basis is Article 6(1)(c) of the GDPR:
  - o the right of access to your data,
  - o the right to rectification of your data,
  - the right to restrict processing,
- where the legal basis is Article 6(1)(f) of the GDPR:
  - the right of access to your data,
  - o the right to rectification of your data,
  - o the right to erasure of your data (right to be forgotten),
  - o the right to restrict processing,
  - o the right to object to the processing.
- 9. You may withdraw your consent at any time by sending an email to the address provided above or in person at the Controller's registered office. The withdrawal of your consent does not affect the lawfulness of the processing carried out on the basis of the consent prior to its withdrawal. After the withdrawal of your consent, the data will be processed for the purpose of protection against claims (Art. 6(1)(f) of the GDPR) for a period set forth in applicable legislation, i.e. a maximum of 3 years.
- 10. The right to lodge a complaint with a supervisory authority:

If you see violations on the part of the PDC in terms of the security of data processing, you may lodge a complaint with the supervisory authority for the protection of personal data, i.e. the President of the Office for Personal Data Protection.
